To date, we have provided aftercare services to more than 200 survivors of human trafficking. / RESTORATION: We provide restorative care to survivors of human trafficking through our two aftercare homes in Kampala, Uganda. in 2016 we served 58 survivors of trafficking and we saw 9 Survivors graduated and resettled. We also opened new aftercare program for transnational survivors, the first of it's kind in the region. Our social workers provided 416 hours of counseling. 37 survivors were granted education scholarships. Furthermore, our social workers provided 246 art and play therapy sessions. At our aftercare homes, 3,564 healthy meals were served. / PREVENTION: We prevent trafficking through advocacy, awareness, and education. We launched a victim advocacy program in 2016. As a result, 7 cases were brought to court. / PARTNERSHIP: We work together with organizations, governments, corporations, and individuals to share resources and increase impact. We launched anti-trafficking coalition in Uganda to increase partnerships in the sector. We also developed new partnerships to expand prevention and protection efforts.
