TO DATE, WE HAVE PROVIDED AFTERCARE SERVICES TO MORE THAN 200 SURVIVORS OF HUMAN TRAFFICKING. RESTORATION: WE PROVIDE RESTORATIVE CARE TO SURVIVORS OF HUMAN TRAFFICKING THROUGH OUR TWO AFTER CARE HOMES IN KAMPALA, UGANDA.
